Dear Friends of Dahl Memorial Clinic,

The Dahl Memorial Clinic Board of Directors, medical staff, and administrative staff are pleased to present the 2018 annual report to the citizens and visitors of Skagway. There has been a considerable positive impact in recent years from the professional healthcare services offered in this dynamic community. You can read about some of these accomplishments in this report.

Services and programs, only a vision one year ago, have come into full bloom. This is possible through the strategic use of funds from the federal Health Resources and Services Administration (HRSA) 330 grant and applying the suggestions and constructive feedback received in the annual Community Needs Survey. 2018 saw full integration of Athena Health, an Electronic Health Record System which streamlines workloads and increases providers' quality patient care time. Also, when it comes to paying bills, contacting your provider, viewing medical records, or scheduling appointments, this EHR system opens a private and convenient portal of access to every patient.

DMC's dispensary technician is leading the way for our participation in the 340B drug pricing program which can generate substantial savings for patients. Patients can now get refills of certain medications without seeing their provider each time, and a selection of Over-The-Counter (OTC) medicine can be purchased at reception.

We were fortunate this year to afford a sizeable price reduction for New Student and Sports physicals, offering a quality of life incentive for families when considering Skagway as their year-round home.

The Board of Directors is committed to living up to Dahl Memorial Clinic's mission statement to provide comprehensive primary, preventative, and emergency health care services for anyone who visits or depends on this community health center. We have a vested interest in an organization which provides care that betters the lives of our neighbors, friends and family. This dedication was formally acknowledged in 2018 by Mountain-Pacific Quality Health (www.mpahf.org). Holding state and federal contracts to oversee quality of care in our region, MPQH bestowed Dahl Memorial Clinic



with its highest recognition, the Alaska Primary Care Quality Excellence Award.















SERVICES PROVIDED in the 2018 Calendar Year

TYPE of APPOINTMENT SCHEDULED for 5,633 PATIENT VISITS



Operating Support & Revenue







Sliding Fee Scale in FY 2018

As a Federally Qualified Health Center (FQHC), Dahl Memorial Clinic is required to maintain a Sliding Fee Scale (SFS) discount program to minimize financial barriers to care for patients who meet certain eligibility criteria. Using the federal poverty guidelines for Alaska, patients can qualify for one of four SFS Levels: Pay 75%, 50%, 25% or the Nominal Level which is currently a payment of \$20 per visit.



Grant Funding Received

43% of our total funding in FY 2018 was received from the following Federal Grants.

- Quality Improvement Award. One-time supplement. This funding was received in recognition of the utilization of data collected in our Electronic Health Records system. We were able to hire a temporary dispensary technician with this grant.
- AIMS Award Access Increases in Mental Health and Substance Abuse Services (AIMS) Supplemental Funding Technical Assistance. Funding was used to locally address the opioid epidemic sweeping our nation. The clinic was able to purchase a behavioral health, and telehealth cart with these funds and, additionally, sent two providers to the American Society of Addiction Medicine conference for training in addiction medicine.
- Federal Health Center 330 Grant
- ❖ Medicaid Meaningful Use Award. Through the use of technology, our providers are able to deliver up to date medical information to patients in a timely manner. By surpassing technology benchmarks set by Medicaid, two of our providers qualified for this award. Some requirements for this program include the following: electronic ordering for labs, medications, and x-rays; providing records and care summaries to patients through the online Patient Portal; and submitting vaccination information electronically to the State Vaccine website.


71 pediatric dental visits were free of charge. Grant funds in the amount of \$21,436.32 were utilized for these visits.

Advanced Trauma Life Support (ATLS): developed by the American College of Surgeons.

Pediatric Fundamental Critical Care Support Class (PFCCS) prepares critical care practitioners to deal with acute deterioration of critically ill pediatric patients for the first 24 hours until transfer or appropriate critical care can be arranged.

DOT certification through the Federal Motor Carrier Safety Administration (FMCSA). This certification allows the provider to perform the physical exam required by the DOT which impacts many of our employers here in town who require drivers to have this endorsement.
